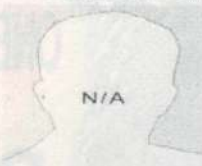
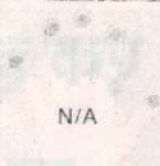

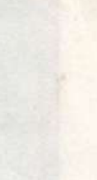

And whereas it is necessary to declare the aims and objects of the public charitable public Trust, being constituted under these presents.

Now this indenture witnesses as follows:-

1. That, in order to effectuate his aforesaid desire, the President has set apart and handed over to the trustees, a sum of Rs. 25,000 (Twenty five thousand) (hereinafter called the Trust Fund which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part there of might be converted invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents, and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained. That the name of the trust shall be "**HARISH CHANDRA PRASAD THAKUR SOCIAL & EDUCATIONAL TRUST**" and office will be situated at **BISHANPUR (JITWARPUR), DISTT.-SAMASTIPUR** and/or at such other place or place as the trustees may decide from time to time.

2. **That the objects for which this trust is established are:**

- [A] To set motion and play a proactive role in giving direction for a quiet social movement/ revolution for socio economical, educational, cultural, scientific, technical, financial, ethical prosperity and take spearheaded initiative to spread the gain or prosperity in the benefit of throughout masses of world of living creature.
- [B] To organise, promote, undertake, sponsor, carryout, all programmes for the benefit of naturally challenged person, schedule caste, schedule tribes, people under poverty line; old-aged, widow, and religion such as :-

- (i) To open, run, continue an educational and vocation institution in healthy surroundings to provide medical, engineering and other allied technical education.
- (j) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help with other necessary requirements.

No members of the Trust shall have any personal claims on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of Trustee.

[H] To accept loan, Grant-in Aid, donation (either in cash or kind), subsidy or other assistance lawfully, either form national and/or International agencies for the attainment of the objective of the Trust.

- [J] To set motion and play a proactive role in giving direction for a quiet social movement/revolution for socio-economical, educational, cultural, scientific, technical, financial, ethical prosperity and take spearheaded initiative to spread the gain or prosperity in the benefit of throughout masses of world of living creature.

To give special attention about the Right to Information among general people by means of Seminar, Sangosthi, Poster, Pumplet, Nukkar Natak etc.

3. All the activities shall be Non Profitable and shall be done on **No Profit- No Loss** basis.
4. All the incomes, earnings, movable/ immovable properties of the Trust shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the deed of the Trust and no profit there of shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past member of the Trust or to any person claiming through any one more of the present or the past members. No members of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of his membership.
5. That the Trust Fund may be augmented by the income from the initial fund also by donations and other contribution from time to time.



6. That the Trust Fund may shall not be applied for any purpose other than those specified in para 3 here in above unless the other objects added to the trust objectives.
7. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the Trust.
8. Subject of the provision of Income Tax Act. 1961 as amended by from time to time, the Trustees will keep the Trust Fund of such portion there of, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or mortgage by way of fresh charge on any immovable property in India of free-holder lease-hold tenure, and may deposit the amounts with any scheduled Bank, Company or private firm any individual on such terms and conditions as they think fit, in the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply, in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute discretion to sell the Trust fund or any part there of and any such immovable property purchased by them under the power aforesaid and any other shares, securities etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon the Trusts and with the subject to powers and provision including an all the posers contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.

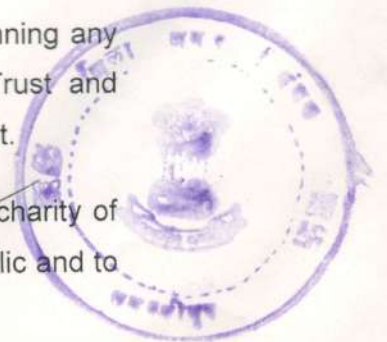

- (iii) To sell, dispose of, alienation or otherwise deal with any property comprising the Trust Fund.
- (iv) To open account in the name of the Trust, with a bank or bank to operate such account and to give instruction to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (v) To adjust, settle, compromise, compound refers to arbitration, all actions, Suits claims, demands and proceedings regarding the Trust Fund.
- (vi) To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or presidents or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- (vii) To make very later or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs there of and/ or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- (viii) To start, abolish discontinuations and restart any charity of charitable institutions for the benefit of general public and to

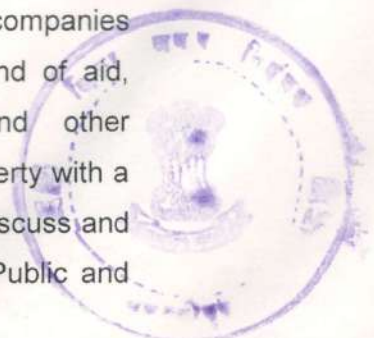

- (ix) To set a part and/or allocation the whole or a part of the income or the corpus of the Trust Fund or the part there of for any of the objects of the Trust.
- (x) To join, co-operate or amalgamate this Trust with other or others having kindred or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- (xi) To give aid by way donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organisations or Trust in India which may have been established or which may hereinafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institutions, societies, organisation or Trustees to start maintain, or carry out such charitable objects.
- (xii) To settle all accounts and compromise, abandon, or refer too arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- (xiii) To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any other purpose of these presents, and it shall be lawful for the Trustee to make such borrowing on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (xiv) To apply to the Government, Public bodies, Urban, Local, Municipal, District and other bodies corporation, companies or person for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance including lease and substance of property with a view to promote the objects of the Trust and to discuss and negotiation with the Government Departments, Public and

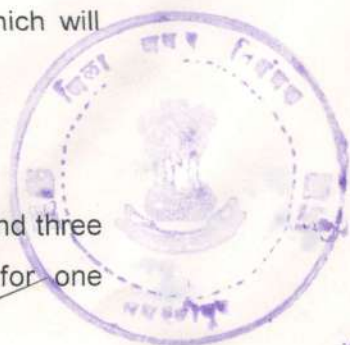

- (xv) To take over or amalgamate with any other Charitable Public Trust, Trust, association, or institution with similar objects.
- (xvi) To take over, acquire, manage, control or aid any existing institutions or institutions having objects either wholly or in may be thought expedient.
- (xvii) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities, and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- (xviii) To take land/property on lease and then after sublease the land property to the farmers and other organizations like co-operative/society/urban public bodies/gram panchayat or any being thereof in rural area/local municipal/district and other bodies corporation/ company of farming/ agriculture/ plantation purpose.
10. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
11. Full Time working Trustees will be entitled to and also reasonable honorarium as decided may reimburse themselves of all expense actually incurred by them in connection with the Trust or their duties relating thereto.
12. All decisions will be based on majority opinion which will include the chairman, Secretary, Treasurer.
13. A person shall cease to be a Trustee either :-
- If he without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year, whichever is longer, or

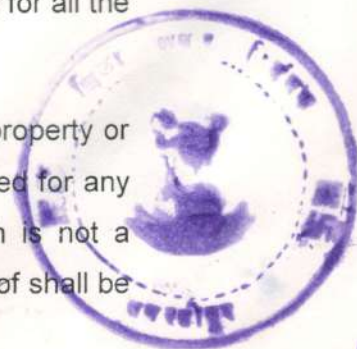
- If he is requested to resign by 2/3<sup>rd</sup> or as near there to as possible of the remaining trustees.

18. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions thereof shall be construed accordingly.



19. Working areas of the Trust will be all over India and all other countries.

20. Two-thirds majority shall constituted the office of the Trust at Kashipur, Samastipur unless changed by the Trustees.

21. **POWER & FUNCTION OF THE OFFICE BEARER PRESIDENT:**

The President shall preside at all meetings of the Trust, when he is present and shall exercise such other powers as are conferred upon him by these rules the President Signed notice in a shorter period. The decision of President that a resolution has been carried or lost shall be conclusive, unless such a decision is challenged and a vote is demand, on voting demand, the same shall be taken in such manner as the President may in discretion determine.
